Medical services performed in 2018 included pregnancy testing, ultrasounds, as well as STI testing and treatment. Overall the number of clients more than doubled. Among other statistics, STI testing, which began in 2017, was up 243%, while pregnancy tests were up 79% in 2018 compared to 2017. Total hours open for clients increased in 2018 to handle the extra clients and services. Employee hours, number of volunteers, and volunteer hours also increased significantly.

Education services in 2018 included lessons on pregnancy, parenting, child development, healthy relationships, and life skills, to name a few. The number of client visits and client lessons was about the same as in 2018 compared to 2017.
